- 3. Dojo Cleaning—Mark and Connie leaders of Creston Combat Fitness have agreed to continue cleaning the dojo once/week, using cleaning supplies purchased by the Judo Club.
- 4. Request for hand sanitizers placed at the entrance to the dojo, in/outside the bathroom doors
- 5. Lease agreement—5 year lease agreement has expired this month. Expecting a minimum of \$25 increase in rent per month. Discussion had regarding a preference for a 2 or 3 year lease with a clause added permitting us to sublet, so the dojo space can be used more often. Any additional group interested in subletting would require their own insurance.
- 6. Tae Kwan Do Instructor—approached Leelen to use the dojo, may attend Combat Fitness. Considering we are unable to sublet at this time we cannot agree.
- 7. Terry Rendek has 20 red mats he is willing to sell to the club for \$3200. Discussion around possible cost share with Kootenay Region to complete the Kootenay mat set, so we do not have to borrow to complete full competition area and safety mats for tournaments.
- Mark had a variety of different sized Gis purchased for trial or to purchase at registration night.
